Purpose

This declaration is issued for the assessment of compliance of the packaging with the applicable requirements of Regulation (EU) 2025/40, on the basis of the information available and the documentation supplied by the manufacturers of the materials used, in accordance with the supply-chain information obligations under Article 16. In its capacity as packaging manufacturer, Silvano Plast states that it has assessed the applicable PPWR requirements on the basis of the available information concerning the materials and production processes.

Article 5 - PFAS and restricted substances

Assessment status: COMPLIANT on the basis of the available information. According to information received from raw-material suppliers and the available technical documentation, PFAS are not intentionally added to the formulation of the materials used to manufacture the packaging. The assessment is based on supplier declarations and available information on raw-material composition. Any specific analyses, where available, are retained in the internal technical documentation.

Article 5 - Heavy metals

Assessment status: COMPLIANT on the basis of the available information. The raw materials used comply with the applicable requirements concerning heavy metals in packaging, on the basis of supplier declarations and regulatory information.

Article 6 - Packaging recyclability

Assessment status: ASSESSED. Recyclability was assessed considering the packaging composition and structure, material characteristics, technical information from raw-material manufacturers and applicable design-for-recycling criteria. The assessment considers the complete structure of the packaging placed on the market.

Article 7 - Recycled content in plastic packaging

Assessment status: N/A / applicable according to customer specification. The standard product does not intentionally contain recycled plastic material. Declared recycled content: 0%.

Article 8 - Bio-based feedstock

Assessment status: N/A. The standard product does not intentionally contain bio-based raw material.

Article 9 - Compostable packaging

Assessment status: NOT APPLICABLE. The supplied packaging is not designed or marketed as compostable and is not certified under UNI EN 13432.

Article 10 - Packaging minimisation
